## Slavery and Human Trafficking Statement

Cardiff and Vale College (CAVC) believes that it is crucial when acquiring goods and services that this is done without causing harm to others. We are fully committed to acting ethically and with integrity in all its business dealings and relationships.

In so doing, CAVC supports the UK Government's approach to implementing the UN Guiding Principles on Business and Human Rights by informing our staff, students, governors and stakeholders about our policy with respect to modern slavery, human trafficking, forced and bonded labour, and labour rights violations in its supply chains.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our Group's slavery and human trafficking statement for the financial year ending 2024.

CAVC is taking steps to ensure transparency in its supply chains and advocates avoidance of child labour, respecting human rights and avoiding exploitation in its commitment to sustainable and responsible procurement.

CAVC has identified the following categories as of being of high risk - Clothing, Food, ICT Equipment. Consequently, these are areas where it will concentrate its efforts.

Suppliers within these areas will be asked as a minimum to commit to the Base Code of the Ethical Trading Initiative (ETI). The ETI Base Code is founded on the conventions of the International Labour Organisation (ILO) and is an internationally recognised code of labour practice, requiring that:

- Employment is freely chosen
- Freedom of association and the right to collective bargaining are respected
- Working conditions are safe and hygienic
- Child labour shall not be used
- Living wages are paid
- Working hours are not excessive
- No discrimination is practised
- Regular employment is provided
- No harsh or inhumane treatment is allowed.

Looking to the future, CAVC expresses its commitment to:

- Better understand our supply chains and work towards greater transparency and responsibility towards the people working within them.
- Monitor areas that represent a risk, working with suppliers, framework organisations and franchisees, to closely monitor those supply chains.
